CHAIRMAN'S REPORT

I would like to start by thanking you all for making the time to attend today and for your efforts during the past year. Without you, and all the other volunteers both in our sport and within your clubs we could not function as well as we do.

The year has been an extremely busy one with a number of key events taking place

The office re-structure has been recently completed with the formalization of John Payne as CEO, Wilson as Communications Assistant and the recent addition of Anthea Evans as Office Manager.

Over the year James Davidson resigned form NZWP

We believe that the clubs and the Regions will see a marked step up both in communication and support as a result of this restructure. It will also enable John to spend more time on both implementing the Business Plan and on finding other sources of revenue.

He will also be working on bringing the Regions into reality and assisting them in finding Regional funding. This is the area where significant number of grants are now being distributed and can only assist in supporting our players

We also welcome a number of new Board Members. Alex McKenzie has joined us as an Elected Director and is a welcome introduction of youth onto the Board as well as being closer to our senior players. We also welcome Viv Scott & Anthony Quirk to the Board as Appointed Directors. Viv works on a number of Boards and her Governance experience will be appreciated in assisting us in carrying out our functions correctly and efficiently.

Anthony has considerable accounting skills as well as providing both business acumen and a breadth of knowledge across the commercial spectrum in New Zealand

Both these functions were highlighted as requirements in the Board review carried out last year

The Strategic plan as presented to all the Clubs last year still forms our primary direction and the Business Plan for 2017 has been presented to the Board and accepted.

The Financial result for the year is disappointing with an overall loss of \$57,516. This loss is primarily due to the loss incurred in running the Women's World Youth Championships.

The budget set for 2017 redresses this to a better than break even with the intent of a full recovery in 2018 being a Pan Pac's year. Our one year float remains in place

With respect to the two major events they were both run operationally successfully.

Pan Pacs was run early in the year out of West Wave and generated a significant profit. This was the first major tournament run by the new office and the review highlighted several potential areas of improvement particularly in the revenue gained.

The Women's World Youth Tournament was an outstanding operational success with NZWP receiving high plaudits from FINA who indicated that it was as good an event as they had ever run. They indicated a keenness to run future events in New Zealand

It did however show a significant financial loss. Whilst the expenses and the bulk of the revenue was as per the budget originally set. The major loss was incurred as a result of the original budget presented to the Board showing an income of \$195.00 per bed night whereas FINA decreed that we could only charge \$161.00. This immediately cut revenue by approximately \$80,000. Again a review has been carried out and the recommendations made will be acted upon.

On the positive side not only was it a huge operational success but through the efforts of Chris Key a large number of future potential sponsorship options were opened to us. These will be followed up and hopefully bought to fruition during the coming year.

He has also assisted us in developing an overall marketing strategy for our sport. We also received good media coverage and the live screening was a huge success

I would like to formally THANK both the Office and all our volunteers who worked tirelessly on these two events and in the case of the Women's World Youths these were ably led by Jeanette Tobin.

Neither event would have been successful without the commitment of these volunteers.

This coming year we are involved in the World Masters Games and whilst not a revenue earner for us it is bringing a number of our "older" players back into the sport. I would like to thank Hibiscus Coast for putting their hand up to act as the "Host Club" It is really appreciated and refreshing to see our younger clubs commitment to the sport in general

Tonight also sees the inaugural "Annual Awards" dinner. We are looking forward to this becoming an annual event supported by the whole sport in giving us the opportunity to acknowledge both "Excellence" and "Commitment" to the individuals within our sport. I look forward to seeing you there this evening and in the future

I also take this opportunity to thank all our Referees, Coaches and Managers. Their jobs can be thankless, arduous and demanding often for little or no financial gain but out of love for the sport. Their input is both invaluable and appreciated.

We now have a formal Referees Commission that will work on not only appointments but on referee development throughout the country including grading and regulations. This is being led by our Senior Referees. This is a very positive step forward in providing top quality referees.

Finally I'd like to thank the Board for their contribution to the sport over the year. There have been a number of issues requiring attention and their commitment has been 100%. Chris Hayward continues to attend and his contributions remain appreciated and constructive

Looking forward to the coming year I believe that we have an office that will improve in their running of the sport and in assisting the Regions & Clubs

I also believe that you now have a Board that is focused solely on the Development of the Sport as a whole. The Board works well in an open manner and frank manner

As a final word I would like to reiterate my words of last year that, as a sport, we must look forward and be positive. I believe that a few small steps have taken us in the right direction. If we all pull together for the good of the sport, sometimes putting our own or club interests aside then we can make Water Polo a truly National Sport with the increased prominence that it deserves.

We have a great sport

Once again I thank you all for your continued support and look forward to the year ahead.

OPERATIONS REPORT

PARTICIPATION

Water Polo for Everyone

1 - Player Numbers

Key measurement

Our key measurement for participation is the number of people playing our sport.

Players fall into 4 categories: Flippa Ball, Intermediate School, Secondary School, and Club players. Flippa Ball teams fell to 640 teams as a couple of leagues have ceased to operate. We are looking at increased leagues in 2017, with an increase in team numbers. School numbers have been constant with club players increasing by 7%.

Club Players

Overall club numbers increased from 1830 to 1963 playing members. The increases were in the younger and older age groups. Pan Pacs U20's and the Senior Tier 2 competition helping to retain senior players.

Sport distribution across NZ

The areas that had player increases were: Waikato, Southland, Palmerston North and Wellington in all their clubs. The rest were stable.

The Future

With excellent growth in under 12 numbers we are expecting under 14's and under 16's to continue to grow. The continuation of the National Tier 2 tournaments and the re-introduction of under 21's are expected to retain more senior players. The combination of introduction and retention is expected to boost our numbers to the point that available pool space will constrain them again.

2 - Coaches & Officials

Development

Once again, a big thank you to our referees, coaches and other officials; without the huge effort you all put in our sport would be in poor shape.

Officials' and Coach Development is key to any sport and water polo is no exception. Coaches, referees, goal judges and table duty personnel need education and experience, just as players and coaches.

In 2016 NZ Water Polo continued to deliver, where possible, Referee Workshops, for example prior or during National Championships, as well as mentoring and supporting referees.

Participation continued

3 - Facilities

Availability

Deep water facilities continue to be an issue. Councils are trending towards leisure centres with slides, wave pools etc. as evidenced in Albany recently. New pools that are suitable to Water Polo have recently tended to come about through private/public partnerships, such as the National Aquatic Centre and private schools such as St Cuthbert's and Diocesan. This may well be the future and we need to be involved in the planning of such facilities.

The good news is the new pools in Christchurch are looking at a 2020 opening.

4 - Competitions and Events

Competitions

We have a new Competitions Manager – Fabian Wanrooij started in January 2016.

In 2016, with the usual excellent support of the volunteers, we delivered Pan Pacs, U16 and U14 National Championships and the FINA World Women's Youth Championship. Congratulations to all our clubs for their achievements and efforts. An overview of national championships rankings can be found further on in this report.

2016 FINA Women's World Youth Champs

This was held in the Sir Owen Glenn National Aquatic Centre, AUT Millennium. This was the first major international event to be held there. FINA officials were very complementary on the way this event was run, as were the teams that participated. Eelco and his team worked incredible hours to achieve this and it is full credit to them that the event was such a success.

National League

The National League in 2016 reverted to the home and away format with clubs doing the hosting apart from the opening neutral weekend in Rotorua and the finals weekend in Auckland.

National Teams Programme (NTP)

The Olympics are our Goal

Following on from our 2015, annual report statement: the Olympic Games are the target event in mind, and this is behind all we are trying to implement at any level within our programme – it is very pleasing to see this is now also the general 'reason-for-being' adapted by our players, coaches and management teams.

A highlight for 2016 was therefore the Olympic Qualification Tournament participation by our senior women's team from March 21-28 in Gouda – the Netherlands. Our women performed well, especially with a solid result against the hosts the Netherlands; after a 5-5 halftime score the final result went to the Netherlands 9-6.

Dream - Believe - Achieve

NTP Booklet

Early in 2016 we designed, and started implementation of, the National Teams Programme Booklet; a template resource which outlines the multiple year campaigns for our three (3) main target age groups:

- Youth; 2016 was a FINA Youth World Championships year
- Junior
- Senior

The NTP Booklet has also been the template for our 2017 campaign plans, targeting the following main events:

- FINA Junior World Championships; for players born in 1997 and later
- FINA World Championships; women qualified only
- FINA World League Intercontinental Tournament; senior men only
- FISU World University Games; women only

Our vision: **New Zealand teams competing for medals on the international stage** became more realistic during 2016 when some of our teams showed how much progress had been made over the past calendar year especially:

- Born 2000/u16 NZL Girls during the post Pan Pacific Trans-Tasman Series
 - NZL deservedly found themselves up by several goals at the start of the fourth quarter in both the first and the second game of the series, but were unable to keep this gap and lost by one goal twice. A great learning experience; the reason why we play these games.
- Born 2000/u16 NZL Boys during the post Pan Pacific Trans-Tasman Series
 - The NZL boys played good first halves of games one and two. Game three was a real spectacle where NZL showed to possess as much skill and talent as their Australian peers. Thirty-five goals during this game were a treat and the boys definitely took that performance as an indication of their potential
- NZL Youth Men beating China 13:12 during the 2016 FINA World Men's Youth Water Polo Championships
 - The NZL Youth Men found themselves in pool play with Croatia, Serbia, USA and China; in all games the men showed to be competitive, especially in the first half of the games. Croatia and Serbia are absolute powerhouses and playing under the test-rules with 25' possession clock, nine field players only per game and 5 v 5 format, the men showed their potential. The game against Kazakhstan was the only

underperformance. A very solid win v South Africa was a good finish. A special mention to the preparation in Herceg Novi, Montenegro, which was excellent if not too short. We have established excellent relationships is this water polo centre and have made this a pivot destination for the men's programme. A special thank you to Goran Sablic and Davor Carevic for taking over the team in June and to Nicola Ellis for managing this group of talented players

- NZL Youth Women's results v the top 3 nations during the 2016 FINA World Women's Youth Water Polo Championships, as well as beating Canada finishing $10^{\rm th}$

- NZL Schoolgirls winning the 2016 Tri-Nations and Trans-Tasman Series;
 a three-peat

- NZL Schoolboys winning the 2016 Tri-Nations and Trans-Tasman Series; back-to-back. Special mention to Rawhiti Teokotai-White who got appointed head coach on very short notice and Joe Bensley who stepped in as assistant coach; managed by Karen Jensen See International Events in New Zealand section.

By expanding the RTC programme as well as the inclusion of NTP squads into the 2016 Pan Pacific Youth Festival (playing within an age group division higher), our **mission** to:

To create and deliver a benchmark, sustainable and elite programme which fully develops our players' potential in and outside the pool was also further built on.

The past year

International Events in New Zealand

2016 was the biggest year in NZ Water Polo's history. On top of the usual, already extensive, calendar, 2016 was also a Pan Pacific Youth Water Polo Festival year and it was the largest edition ever held. As mentioned before the NTP had four teams entered as this event provides our players with excellent development opportunities and to play not only against older players, but more importantly add international experience.

After the Pan Pacific Youth Festival our main focus was on the 2016 FINA World Women's Youth Championships in Auckland from 12-18 December. A massive job, which with the help of many extremely dedicated volunteers and fantastic sponsors was an enormous success. The feedback of the fifteen participating countries could not have been more positive and also FINA was unanimous in their feedback: a fantastic championship delivered in a truly world class manor. The FINA Bureau (board) Liaison credited us with the 'best ever'.

The New Zealand Women's team beat South Africa convincingly in their first game, then had two losses in pool play against Spain and Russia who both went on to make the final. The game versus Russia was an amazing game by the New Zealand team and it was only until the last quarter for the Russians to win the game; they went on to win the gold. In the crossover game to make top eight New Zealand faced Italy and again performed above expectation and led 2-0 as well as, again, staying in the game till the final stages. Italy ultimately took the bronze medal. Facing Canada in the semi-final for the places 9-12 our youth women took the win, an indication and reward for their hard work and progress. The last game versus Australia didn't get us the result we were after and Australia deservedly won. All in all a great tournament from New Zealand and lots of credit was gained in the eyes of the international visitors and delegates; topped off with Antonia Young getting awarded the Goalkeeper of the Tournament Award chosen by the FINA Media.

Immediately after the FINA World Youth Championships the 2016 School Tri-Nations and Trans-Tasman Series took place. A special mention to Mr. Chris Hayward for ensuring this event was very well organised and delivered. Both New Zealand teams won not only the Trans-Tasman Series, and successfully defending their respective Shields, they also took out the Tri-Nations (Australia, South Africa and New Zealand); compliments to both groups and their management.

SUSTAINABILITY

Secure our Future

2016 result

Our operating activities recorded a loss of \$54,643, this was due in large part to the loss incurred from FINA World Women's Youth's. This loss was the result of FINA set rates for accommodation being lower than those in the original budget. In 2017 we are budgeting to make a small profit, as is usual in non-Pan Pac years. However we have made it a goal to recover the loss made in 2016.

The National Teams programme recorded a deficit of \$2,873.

Distribution to national teams

A deficit is the normal result since we adopted the policy in 2014 of a funds distribution to the National Teams Programme. This is because the funds held are recorded in accumulated funds under the heading of HP Distribution Fund. (2016 balance still to be utilised is \$61,172)

Comments on the financial report

Obtaining funding is getting more and more difficult for National Sports Organisations (NSO's). In July Sport NZ reduced our annual funding by \$50,000.

Having said that we are focusing on obtaining as much funding as we can and are exploring all opportunities.

Foundation

The foundation was registered on 25th September 2014 as a charitable trust. The Board and The Trustees are looking at an appropriate strategy for the Foundation going forward. The balance in the Foundation account is \$31,846.

CONCLUSION

Summary

We were successful in:

- Improved retention of senior players.
- A 7% increase in total club players.
- The National Teams programme implemented its booklet giving the future direction of the programme, with Olympic representation the goal. Our Senior Women finished 9th at the Olympic qualifiers, Women's Youth 10th at Worlds and Men's Youth 17th at Worlds.
- Delivering a very accomplished and professional FINA event that FINA themselves said was the best ever.
- Increasing the profile of the sport through the publicity generated by the FINA event.
- Developing marketing plans for NZ Water Polo

Looking Forward

Domestically

We will be leveraging off the raised profile of the sport.

The launching of the Referees Commission will mean improvement of our referees both in number and in quality.

We are looking to increase the retention of players through an under 21 competition.

NTF

We are working towards Olympic qualification

The Senior Women's team are going to the World Championships in Budapest and the University Games in Taipei.

The Senior Men's team have been to Australia and will be playing in World League, with a European trip later in the year.

Junior Men's and Women's teams are attending World Championships in Europe.

With the people involved in our sport we can and will succeed. We realise we never achieve quickly enough but we do strive to be fair and clear at all times.

We would like to stress once more that all we do and achieve in this sport is only possible through the support of our volunteers, officials, supporters, parents and sponsors. Allan Anderson

Allan Anderson passed away on 13 May 2016. He was aged 77. Allan, also well known as 'Grumpy' to his friends and many in the New Zealand water polo fraternity, was heavily involved in New Zealand water polo circles from the 1950s. He played water polo for the powerful Waitemata Club and was in the teams which won the Ryan Cup in 1957, 1968 and several other years in the intervening period. The club senior team was virtually unbeatable through those years in the Auckland competition although stories abound as to the fierceness of the rivalries – including the need for the police to intervene when spectators became over enthusiastic.

Players too were tough. It was a period when one referee was required to cover the whole pool. Defense was often over-vigorous. Allan was known as a staunch defender although his attacking skills were influenced by two factors:

The first was when Andrew Kocsis fled Hungary in 1956. He had been in the wider Hungarian squad preparing for the Melbourne Olympic Games when the uprising lead his family to come to Auckland. Andrew, with limited English language skills, taught the Auckland players how to catch and throw the ball properly, how to use the width of the pool and how to counter attack. In the early stages he even had these men sitting in chairs practicing their ball skills. Allan and his Waitemata and Auckland teams were major beneficiaries of this advice.

The second was when Allan lived in Sydney and played premier grade water polo for Bronte. Not only was it an outstanding team but it included several NSW representatives and Dick Thornett, who played water polo, rugby and league for Australia, and Jon Konrads, a swimmer who was an Olympic gold medalist and world record holder. In that company, Allan had to swim seriously. He got very fit and played good water polo. He was selected in the New Zealand team which competed in Australia in 1964.

Allan also served NZ water polo as a referee, coach and administrator.

He was an excellent NZ A grade referee and served as an examiner on behalf of the NZ Water Polo Referees' Association. It was said that those who suffered and meted punishment in the vigorous men's water polo of the time often made the best referees. Apparently they understood what was happening in the hustle, bustle and underwater shenanigans – and refereed accordingly. He was firm, single-minded and did the job well.

Allan, along with several Auckland teammates, helped to establish secondary schools teams in Auckland by each coaching a team. Allan and Reg Harker coached their old school: Seddon Tech (now Western Springs College).

In 1976 the NZ Water Polo Board held an Advanced Coaches and Referees Seminar in Christchurch. Allan played an important role and was able to exercise influence through his widespread knowledge and experience.

Water polo was not Allan's only sporting involvement. He and his young mates used to visit Waiheke Island and do beach patrols. Then they joined the newly formed Red Beach Surf Lifesaving Club – and competed with success including winning the Nelson Shield: the NZ Six-man Rescue and Resuscitation Championship. He played in the Auckland U-21 rugby team which played in a curtain-raiser for the 1959 NZ v Lions match in Auckland. He was cox for a crew during the 1950 Empire Games in Auckland. He played golf with enthusiasm. He was a part owner of several winning racehorses including 'Grumpy's Choice' and another which won the Victoria Gold Cup at Caulfield in 2001.

Allan was enthusiastic, good humoured, friendly and helpful to those around him. He will be sorely missed.

Notes to the Consolidated Financial Statements

For the 12 month period ended 31 December 2016

1. Statement of Accounting Policies

A) i) Entity Reporting

New Zealand Water Polo Association Inc. is an Incorporated Society registered under the Incorporated Societies Act 1908 and a registered Charlty under the Charities Act 2005. The Society established the New Zealand Water Polo Foundation under the Charitable Trusts Act 1957 on the 25 September 2014. The objective of the foundation is to support sporting or charitable purposes and in particular, through education, coaching grants and the development of facilities, to encourage the participation of youth in NZ in the sport of water polo.

For the purposes of financial reporting, the society is a public benefit entity (not-for-profit).

The financial statements have been prepared in accordance with New Zealand Generally Accepted Accounting Practice ("NZ GAAP"). For the purposes of financial reporting they comply with PBE Accounting Standards Not-For-Profit and Tier 2 reduced disclosure concessions have been applied.

The society has elected to report in accordance with PBE Accounting Standards Not-For-Profit Tier 2 on the basis that it does not have public accountability and has total annual expenses of less than \$30 million.

The Trust has adopted the Disclosure Initiative (Amendments to PBE IPSAS 1). This has resulted in a number of changes to the format and presentation of the financial statements designed to enhance reader comprehension and disclosure effectiveness.

The statement of cash flows has been prepared using the direct method. The financial statements are prepared on an accrual basis.

The consolidated financial statements are prepared on a going concern basis.

The consolidated financial statements are presented in New Zealand dollars has been rounded to the nearest dollar, except when otherwise indicated.

Valuation of Inventories

Inventories are stated at the lower of cost and net realisable value after making due allowance for damaged and obsolete stock.

Goods & Services Tax

All amounts are shown exclusive of GST, with the exception of accounts receivable and accounts payable which are shown inclusive of GST.

Cash and cash equivalents

Cash and cash equivalents includes cash on hand, deposits held at call with financial institutions, other short-term, highly liquid investments with original maturities of three months or less that are readily convertible to known amounts of cash which are subject to an insignificant risk of changes in value, and bank overdrafts.

D) Changes in Accounting Policies

There have been no changes in Accounting Policies. All policies have been applied on bases consistent with those used in previous years.

E) Comparatives

The current period financial statements of NZWP are for the twelve months ended 31 December 2016. The comparative figures are for the 12 months ended 31 December 2015.

2. Taxation

The society is exempt from income tax under Income Tax Act 2007 on income earned for charitable purposes in New Zealand.
